Subject: Call for ESG Certifications

The Emilia Chamber of Commerce encourages business competitiveness through the provision of non-repayable grants for the acquisition of services aimed at obtaining environmental, ethical and social certifications and promoting ESG values.

All MPMIs with a registered office/operating local unit in the territorial district of the Emilia Chamber of Commerce are eligible to apply.

Certifications must be issued by a third-party accredited body with an accreditation body present in a member state of the European Union, the United States and the United Kingdom.

Specifically, expenses must be related to:

- A) consulting for obtaining certification;
- B) surveys for initial/final environmental analysis;
- C) training expenses;
- D) expenses invoiced by the certifying body.

The facility consists of a non-repayable contribution equal to 50 percent of eligible expenses up to a maximum amount of \le 14,000 + \le 250 bonus for companies with a legality rating. Minimum investment of \le 5.000.

Applications must be submitted by April 29, 2024.
