Subject: Regional call for “The promotion of circular economy and waste reduction in the regional production system 2025”: summary sheet by Confindustria Emilia-Romagna

With Regional Council Resolution No. 521 of April 7, 2025, the Emilia Romagna Region approved the Call for Interventions For Circularity Of Processes And Development Of Circular Economy Facilities 2025 (ERDF 2021/2027 - Actions 2.6.1 AND 1.3.1).

The measure aims to encourage and support the investments necessary to activate significant actions in terms of the circular economy, incentivizing waste prevention, reuse and recycling interventions, with particular attention to the fashion supply chain and the transition to sustainable production models.

WHAT DOES THE CALL FUND?

- ◆ purchase of plant, machinery, equipment, hardware, tangible capital goods, including used or reconditioned including in the form of lease acquisition and/or through rental;
- ◆ purchase of software licenses or subscriptions for the use of software licenses, patents and services delivered in the cloud computing and software as a service solution (SAAS);
- ◆ carrying out masonry and building works closely related to the installation and laying of machinery, equipment, plant and hardware;
- ◆ purchases of specialized consulting services for the implementation of the intervention and for obtaining certifications related to environmental issues (ISO 14001, EMAS, ECOLABEL, EPD, LCA, etc.).
